

## Sam on the Road...

In the midst of summer the sun is high. In direct ratio to the escalating heat, the pace quickened for our Executive Director Sam Paredes as he was on the road again across California to speak out on behalf of the Second Amendment and GOC.

The activist groups: The Delta Tea Party Patriots of Rio Vista and also the Auburn Tea Party Patriots, booked Sam early in the month of July, while those of the Redding Tea Party were a little later on in the month. Sam gave a **Confrontational Politics** Presentation to the Corning Tea Party Patriots and also the Tea Party Activists in Carmichael, Citrus Heights, and Fair Oaks.

The last half of August is the most intense time for lobbying, and is a daily activity for all of us. This is the time when the bills are coming to fruition, so to speak. They are in the final lap of the process, coming to the floor of the Assembly or Senate for a whole house vote. This is the time, also, when Sam took others with him to the Capitol to spend a day with him, doing what he does, meeting legislators, watching and giving testimony in last minute committees. Sam spent three days with supporters of GOC, giving them the Education and Experience that is part of what GOC does. As Sam tells it, "their eyes were wide with amazement all day long."

September may have been the busiest month of the summer, as Sam started out the month speaking to the Yuba County Republican Party at their annual dinner. Four **Confrontational Politics** Presentations were given; the Sacramento Tea Party Patriots, the Merced Tea Party Patriots, the Loomis Basin Tea Party Patriots and the Golden State Second Amendment Council in San Jose. The Tea Party in Ramona, calling themselves the Ramona Tea'd as an expression of their T'd off anger to unconstitutional government activity, featured Sam as a speaker along with his good friend Assemblyman Brian Jones, who, had had an event the day before at which Sam spoke, also.

As fall sets in, Sam will be appearing in Anderson, California, for the Shasta County Republican BBQ, giving a **Confrontational Politics** Seminar in Turlock and another in San Jose.

## Gun Legislation Wrap-up for 2011

### AB 144 Portantino (D – 44 Pasadena)

#### Open Carry Ban

Status: Signed into law. Becomes effective January 1, 2012.

**GOC Position: Oppose - Makes carrying an unloaded gun in a public place a crime.**

### AB 809 Mike Feuer (D – 42 West Hollywood)

#### Rifle and Shotgun Registration

Status: Signed into law. Becomes effective January 1, 2014.

**GOC Position: Oppose - Requires Rifles and Shotguns to be registered just like handguns.**

### SB 427 Kevin de Leon (D – 22 Los Angeles)

#### Ammunition Registration

Status: Vetoed

**GOC Position: Oppose - Reaffirming and clarifying AB 962 (the ammunition registration law declared unconstitutional as vague and ambiguous by the courts.)**

### SB 610 Rod Wright (D – 25 Los Angeles)

#### Licence to Carry Concealed Weapons (CCW) Conformity Bill

Status: Signed into law

**GOC Position: Support - CCW applicant not required to pay for classes or insurance until he knows his application is accepted.**

### SB 798 Kevin de Leon (D – 22 Los Angeles)

#### Pellet/BB Guns, Air Soft Guns,

Status: Failed in the Assembly Committee on Public Safety

**GOC Position: Oppose – Deletes State preemption on the regulation airguns to allow city, county, local government entities may to individually regulate these products.**

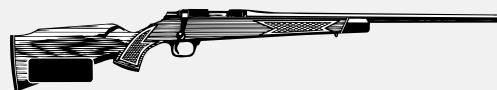
### SB 819 Mark Leno (D-3 San Francisco)

#### DOJ Funding on the backs of gun owners

Status: Signed into law.

**GOC Position: Oppose - Allows Department of Justice to utilize Dealer Record of Sales fees to fund activities unrelated to the purchasing of firearms and processing of background checks.**

The status of these bills is final for 2011. Stand by for a whole new crop of anti-gun bills in 2012.



## Anti-Gun Governor Brown

Governor Jerry Brown can no longer brag about a good record on guns and the Second Amendment. He had every opportunity to maintain a clean record but his true colors came blazing through. As a candidate for Governor, he committed to various organizations that he would be “good on guns”. He also went on various sportsmen’s radio programs to reassure gun owners, hunters and shooters that he would support gun rights. **That was then...**

On Sunday night October 9th, the man behind the curtain was exposed. Under the cover of night, just before the clock struck midnight, Governor Brown wasted a clean record and joined the ranks of his fellow anti-gun governors including Gray Davis and Arnold Schwarzenegger. He chose to sign into law AB 144 – the Open Carry Ban, AB 809 - Rifle and Shotgun Registration, and SB 819 - Converts Dealer Record of Sales from fee to a tax (Creates a slush fund for the Attorney General).

He did veto SB 427 the ammunition registration scheme and he signed SB 610 a very minor improvement to the CCW application process, but that is very little consolation. This is like getting a kiss on the cheek from the Gov. while at the same time he shanks us in the stomach with an ice pick.

Now we know exactly what then-Attorney General Jerry Brown meant when he personally penned an amicus brief to the US Supreme Court asking it to grant certiorari to the *McDonald v Chicago* case which would incorporate the Second Amendment against state and local government intrusion. In his brief, Governor Brown discussed how the reasonable laws of California were not a violation of the Second Amendment. Obviously, he doesn’t believe that the reasonable laws are sufficient and more reasonable laws are needed.

Here is the bottom line. Governor Jerry Brown’s actions have placed him firmly in the anti-gun camp and anybody who says anything different must be basking under the light of a midnight moonbeam.

## Fast and Furious

Scandal Reveals Cover-Up at the highest levels.

Every day there is a new revelation...now we know that Kevin O’Reilly who was a White House national-security staffer for North American affairs, was getting emails from Phoenix ATF Agent William Newell, in 2010. They had a regular conversation going on about the ATF Gun Running Operation as one can see in the documents finally released by the feds to the congressional investigators. Wanting to speak to O’Reilly in person about the matter and of what he knew, the investigating committees were told that Kevin was working in Iraq and “unavailable.” That is serious exile!

Remember Attorney General Eric Holder saying that he had only known about the illegal ATF Operation of walking guns into Mexico a “few weeks ago?” That was asked by Congressman Darrell Issa’s investigative committee last May. Well, amongst the documents recently obtained from the administration is a memo proving the Attorney General knew about the ATF activity in July of 2010. The memo to the AG is from Michael Walther, Director of the National Drug Intelligence Center. It identified the Bureau of ATF&E as the leader in the Fast and Furious Operation...the name given to the Gun Running, Gun Walking enterprise. So, a little over a year ago, the AG knew. It is not hard to imagine that he knew even before that, most likely from the beginning...but that is yet to be verified...it is just not hard to imagine.
