
Texas Governor Greg Abbot's statement is spot-on in capturing the spirit of Scalia – he was as fine a human being as he was a legal giant:

2016 Legislative Update

Here's a partial list of bills your elected officials are pursuing at the Capitol:

BAD STUFF

AB 1663/Chiu [D] OPPOSE

Classifies a semiautomatic centerfire rifle that does not have a fixed magazine with the capacity to accept no more than 10 rounds as an assault weapon. Bans future sale or purchase of most centerfire semi-auto rifles.

AB 1664/Levine [D] OPPOSE

Defines detachable magazine and requires DOJ registration. Bans future sale or purchase of most centerfire semi-auto rifles.

AB 1673/Gipson [D] OPPOSE

Expands the definition of firearm to include an unfinished frame or receiver that can be readily converted to the functional condition of a finished misdemeanor or a felony. frame or receiver. Bans 80%ers.

AB 1674/Santiago [D] OPPOSE

Prohibits purchase of long guns to one a month.

AB 2459/McCarty [D] OPPOSE

Requires all purchases of firearms and ammo to be videotaped that makes facial features visible.

SB 880/Hall [D] OPPOSE

Revises the definition of assault weapon to mean a semiautomatic centerfire rifle, or a semiautomatic pistol that does not have a fixed magazine. Bans future sale or purchase of most centerfire semi-auto rifles.

SB 894/Jackson [D] OPPOSE

Requires reporting of firearm theft/loss to law enforcement within specified number of days; mandates penalties for non-reporting. If you don' report, you are the criminal...

SB 1006/Wolk [D] OPPOSE

Creates the California Firearm Violence Research Center at the University of California to research firearm related violence.

SB 1407/De Leon [D] OPPOSE

Requires a person who manufactures or assembles a firearm to apply for a unique serial number of other identifying mark with the DOJ; requires a firearms eligibility check before DOJ can grant application.

SB 1446/Hancock [D] OPPOSE

Revises the definition of large capacity magazine feeding devices that hold a capacity of more than 10 rounds of ammunition to include those permanently modified to hold no more than 10 rounds. Bans all legally owned 10+ round magazines.

SJR 20/Hall [D] OPPOSE

Urges the Congress to lift an existing prohibition against publicly funded scientific research on the causes of gun violence and its effects on public health and to appropriate funds for that research.

GOOD STUFF

AB 1869/Melendez [R] SUPPORT

Makes the buying or receiving of a stolen firearm with knowledge that the property was stolen, a misdemeanor or a felony.

AB 2340/Gallagher [R] SUPPORT

Exempts from both the gun free school zone and the university prohibitions a person holding a valid license to carry a concealed firearm who is also protected by a domestic violence protective order.

AB 2478/Melendez [R] SUPPORT

Makes firearms offenses punishable by imprisonment (reverts to pre-Proposition 47 statute).

AB 2508/Mathis [R] SUPPORT

Allows a handgun model removed from the roster for any reason other than its failure upon retesting to be reinstated to the roster upon a petition to the Attorney General for reinstatement.

AB 2540/Melendez [R] SUPPORT

Provides an exemption from the sales and use tax laws for the gross receipts from the sale of, and the storage, use, or other consumption of gun safes and trigger locks.

AB 2666/Baker [R] SUPPORT

Provides punishment for subsequent convictions of felons in possession of a firearm.

SB 1332/ Mendoza [D] SUPPORT

Requires the Department of Justice to modify its registration form so that both spouses may register as the owners of the firearm.

Legislative Spotlight It's Big Brother!

That's right, Big Brother is here – and wants to see your face every time you buy a box of ammo or a gun

AB 2459 by Assemblyman Kevin McCarty (D-Sacramento) mandates that every single firearms and ammo transaction be videotaped. His bill would also "require a licensee to ensure that it's business premises are monitored by video surveillance that... visually records and archives footage of every sale or transfer of a firearm or ammunition, in a manner that makes the facial features of the purchaser clearly visible...", say cheese!

There have always been a lot of bad ideas that come out of the Legislature, but this one's near the top of the nonsense chart. For all those liberals who buy guns but don't want anyone to know, we would think this might make them feel *uncomfortable*. But uncomfortable enough to cast a "no" vote? This remains to be seen.

There are far bigger problems than what a liberal might encounter in the aftermath of purchasing a gun – this will impact the privacy for all of us. GOC believes that law abiding citizens deserve privacy every bit as much as someone in the public spotlight.

And this is not just an issue of privacy – it's also an issue of *security*.

According to Forbes, a security researcher discovered it's not that hard to hack a video surveillance system—or more specifically the network video recorder to which it's attached. The "research uncovered flaws in devices that expose the surveillance system to denial-of-service, information disclosure, and other critical flaws—all without requiring authentication. The cameras ... are typically connected to the Internet by design, and these critical vulnerabilities enable an attacker to hack into the system remotely from anywhere in the world."

Wired Magazine has also reported on this, revealing some scary research about popular

Five Degrees To Domination

Sounds ominous but it's not – think of it as an extraordinary *possibility*.

Did you know that in the last election, our statewide voter turnout was just a tad over 42%?

That being said, an uninformed voter is a dangerous one — which is why we are encouraging every gun owner out there to **become informed** — **and therefore armed**. And then we want you to VOTE.

We've made it easy for you - just go to registertovote.ca.gov. And to make certain that "life" doesn't get in the way and keep you from actually getting to the polls on Election Day, consider becoming a "permanent absentee". This means a ballot will come directly to your home before the election - all you have to do is fill it out and drop it back in the mail. It's really as easy as 1-2-3.

CA Sheriffs: NO to Newsom

In a letter to Lt. Governor Gavin Newsom, the California State Sheriffs Association announced their opposition to his fraudulent "Safety for All" campaign to restrict ammo purchases and compel the state to confiscate commonly owned property from the law-abiding.

"Effectively, this measure will create a new class of criminals out of those that already comply with common sense practices that now exist," wrote President Martin Ryan, Amador County Sheriff and PAC Chair Gregory J. Ahern, Alameda County Sheriff. "The focus of efforts to reduce gun violence in this state should be on those responsible for that violence, not those that have no intent to do harm."

The Sheriffs are right on the money when they argue that the initiative "would not prevent criminals from obtaining guns and ammunition via the black market or theft."

Newsom and his anti-gun cohorts will stop at nothing to get the initiative to the ballot — even going so far as to use outlandish and dishonest "statistics" which caught the attention of the Pulitzer prize winning Politifact. In a campaign email blast last December, our Lt. Governor (and presumptive Democrat candidate for Governor) said "So far in 2015, there have been more mass shootings than days." And Democrat Assemblyman Richard Pan added to Newsom's ridiculous statement in a January press release, saying "there were more mass shootings in America where four or more people were killed, than there were days in the year in 2015."

According to the Politifact article, they claimed that Newsom's statements have been "mostly false" and that "from 1999 through 2013, there were about 21 mass shootings each year in the United States, according to a congressional analysis of FBI data."

From GOC's perspective, such dishonesty should spell BEWARE for the voters of California. We believe that once someone lies – politician or otherwise – they have made the decision that you aren't worth the truth and as such, there is really no reason to trust them – ever.

Newsom's "Safety for All" Initiative has been collecting signatures since December 31, and GOC has joined with other strong constitutionally minded groups to wage battle by forming the **Coalition for Civil Liberties.** For more information on the Coalition's efforts, go to www.stoptheammograb.com
