2018 LEGISLATION — WAGING WAR UNDER THE DOME

The second half of the 2017/2018 session is underway and predictably, the leftist legislators are well armed with a bevy of anti-gun bills. The heartbreaking school shooting in Florida has added to their rhetoric, and they have dug deep to figure out what other obstacles they can put in the path of law abiding gun owners.

We aren't just fighting the bad stuff, though – we have some terrific men and women at the Capitol who are eager to defend the 2nd Amendment. Their constructive proposals lead the pack:

AB 986 (Gallagher) SUPPORT

Requires a reduced fee for lifetime hunting and lifetime sport fishing licenses for an individual who is a Veteran.

AB 1931 (Fong) SUPPORT

Makes a license issued to carry a concealed firearm valid for any period of time not to exceed 5 years.

AB 1932 (Fong) SUPPORT

Requires the Department of Justice to furnish the background check report for a concealed firearms license to the licensing authority within 60 days of receipt of the fingerprints and fee.

AB 2067 (Gallagher) SUPPORT

Requires a school district to hire or contract with at least one armed security guard, authorized to carry a loaded firearm, at each school in the school district.

AB 2151 (Gray) SUPPORT

Provides for the issuance of a youth hunting antelope, elk, bear, and bighorn ram tag to a resident of the state for a fee of \$20, and a youth wild pig tag for a fee of \$10.

AB 2733 (Harper) SUPPORT *Sponsor

Deletes the requirement that a firearm be designed and equipped with microstamping technology in order not to be listed on the roster of "unsafe" handguns.

AB 2860 (Allen) SUPPORT

Repeals requirement that the Department of Justice compile a roster listing all of the handguns that have been tested and determined to be unsafe.

AB 3064 (Baker) SUPPORT

Provides for penalty enhancements for subsequent convictions of felons in possession of a firearm.

AB 3117 (Mathis/Dahle) SUPPORT

Hunting non-lead ammo; temporary suspension if the Fish and Game Commission finds that nonlead ammunition of specific caliber is not available.

SB 1092 (Anderson) SUPPORT

Authorizes hunting while using a lawfully possessed silencer that is attached to a firearm with a barrel measuring 16 inches or more in length.

SB 1382 (Vidak) SUPPORT

Permits the locking of a handgun in a specified toolbox or utility box to be compliant with handgun storage laws.

GOC has reviewed the following bills and will be OPPOSING:

AB 1872 (Voepel)

Creates a "carve out" for port authority law enforcement officers; adds to the list who can purchase "off roster" guns not available to the law abiding.

AB 2103 (Gloria)

Extends course training for a license to carry a concealed firearm to at least 8 but not more than 16 hours and to include live-fire exercises conducted on a firing range.

SB 459 (Portantino)

Requires DOJ to conduct inspections of firearms dealers at least every 3 years.

SB 1100 (Portantino)

Prohibits the sale of long guns to any individual under the age of 21.

SB 1346 (Jackson)

States that the existing definition of a multiburst trigger activator includes a bump fire stock or bump fire stock attachment.

AND NOW FOR THE GOC "WATCH" LIST

GOC will be carefully monitoring the following bills. As currently drafted,

they do not represent a direct attack on our ability to own firearms, but due to their subject matter and/or section of the code the bill seeks to change, they merit added scrutiny – some we may end up opposing and others we may support. As you can tell, we have a lot on our legislative plates and we must be on guard because legislative shenanigans lurk around every corner!
