ELECTION RESULTS A RED WHAT?

BRUEN: THE GIFT THAT KEEPS ON GIVING

It's important for us at GOC to keep members up to speed in real time when it comes to Second Amendment news – and sometimes this is easier said than done. By the time this newsletter lands in your mailbox, you may have heard news about a momentous Second Amendment legal event – it's timing coincides with the newsletter – so we will do our best to break down what we know at press time.

On December 12, 2022, Federal District Court Judge Roger T. Benitez (sometimes referred to as Saint Benitez by the pro-Second Amendment community because of his unfailing defense of the Constitution and the Second Amendment in particular) has scheduled a Motion Hearing. This Motion Hearing is set to include the following cases – each of which are to be heard on the same day:

Miller v Bonta (CA Assault Weapons Control Act), Duncan v Bonta (Large Capacity Magazine Ban) and Rhode v Bonta (Ammunition Background Checks).

There are several possibilities of what

might occur. Judge Benitez may do nothing more than hear the oral arguments on all the motions to delay asked for by Attorney General Bonta, take them into consideration for a future decision, or finally, he could reject the Attorney General's motions and issue an order for trial dates for each of the cases.

However, there is one more possibility. Judge Benitez, who has resisted efforts by AG Bonta to postpone and procrastinate, could issue summary judgement opinions on each of the cases. This is particularly noteworthy, given that when the cases first came before him, he ruled they were each unconstitutional.

Judge Benitez has consistently been one step ahead of Attorney General Bonta; he has informed the AG that his office has had plenty of time to consider these cases since they have each been in the judicial system for years. Further, the AG has had plenty of time to prepare given the new standards of review provided by the Supreme Court's NYSR-PA v Bruen decision for Second Amendment cases.

Judge Benitez has seen through the delaying tactics and excuses as to why AG Bonta cannot do his job and basically told the AG that enough is enough. Time to put up or shut up...my words but you get the drift.

Antonyuk v Bruen

On November 7, 2022, Gun Owners of America (GOA), Gun Owners Foundation (GOF) and Gun Owners of California (GOC) secured a preliminary injunction in federal district court against most of New York's poorly named "Concealed Carry Improvement Act." This follows GOA, GOF and GOC securing a

temporary restraining order against the law in October, which was frustratingly blocked by a federal appeals court.

The ruling from Judge Glenn Suddaby, indicated this law has imposed "unprecedented constitutional violations" such as a requiring good moral character, the names and contact info of spouses and other adults in the applicant's home and mandating applicants to disclose social media accounts for review. Further addressed were the onerous restrictions on carrying in public parks, zoos, places of worship, locations where alcohol is served, theaters, banquet halls, conferences, airports and buses, lawful protests or assemblies, and the prohibition on carrying on private property without express consent from the owner. The injunction took effect immediately, despite the State of New York's attempt to delay the injunction.

But anti-gunners are not going quietly into the night; as expected, they filed notice of their intent to appeal the decision – and on Tuesday, November 15, the appellate court gave New York what they were seeking. They secured a temporary stay of Suddaby's ruling.

We do not look at this as a set-back, but rather as a set-up. Judge Suddaby's ruling will serve as the foundation as we proceed up the proverbial court ladder – all the way to the Supreme Court. The anti-gunners are hoping to bleed us dry with legal fees until we reach the point where we can no longer fight back. Your support will keep us in the battle no matter how long it takes.

ANNOUNCING PROJECT PROTECT

As we jump into 2023, GOC is launching a new program and filling what we believe is a vital need. As we've reported, more than 400,000 people became first time gun owners between 2020 and 2021. The numbers show us that people

are starting to wake up to the purpose of our 2nd Amendment; it is our right to bear arms and defend ourselves. We are our first line of defense! You have seen the change out there and so have we. Every year laws are pushed through that restrict our rights and we can all agree that unsettling national events have prompted millions of folks to become gun owners.

That being said, GOC is launching a brand-new program to help Californians in that pursuit. It's called Project Protect. This program is designed to provide resources to CCW instructors across the state and it is our hope to create a place where instructors will be able communicate and provide resources amongst each other. We are looking to pull the strongest cord in the line of defense: we want to network with those who are actively engaged in making sure the public is well-trained in the process of attaining a concealed carry weapons permit. CCW instructors work diligently to be approved and certified by the Department of Justice and local law enforcement, and are a crucial piece in the process of exercising and retaining our rights.

DID YOU KNOW?

Nothing makes a Leftist foam at the mouth more than reading the news about the explosion of gun sales. And it has to be like pouring salt into an open wound to learn that a hefty number of the **39 million gun purchases in 2020 and 2021** are not only women, but a good percentage come from traditionally "gun-less" minority populations.

Obviously, this is great news for the 2A community – the more gun owners the better! What's even more significant is that according to the National Shooting Sports Foundation, there were more than 5.4 million first time gun buyers in 2021 and 8.4 million in 2020. That's 13.8 million brand, new gun owners in the USA.

Here's where it gets interesting for us in California:

In the lawsuit challenging California's ban on semi-automatic firearms and magazines (Miller v Bonta), Judge Roger Benitez mandated that Department of Justice provide gun sales statistics to the court. GOC is quite certain that the DOJ was more than a little irritated; they were forced to admit the following (excerpted from Ammoland, 9/29/22):

"Blake Graham, Assistant Director of the

California Department of Justice provided the following in a sworn document to the court:

The total number of firearms sold in California with background checks in 2020 was **1,165,309**. As of March 12, 2021, the total number of firearms sold in California with background checks in 2021 was **180,058**.

These figures account for all firearm sales conducted through FFLs in the state, including private-party transactions, consignments, and pawn sales.

Graham also provided the number of first-time firearm purchasers, as well as could be determined:

'Based on these parameters, approximately **369,511** individuals purchased a firearm in California who had not previously submitted a DROS application to the Department prior to January 1, 2020. As of March 12, 2021, approximately **42,548** individuals purchased a firearm who had not previously submitted a DROS application to the Department prior to January 1, 2021.'

Of the guns purchased in all of 2020 in California, about 32% were by new gun buyers. Of the guns purchased up until March of 2021, about 24% were new gun buyers."

Doing the simple math, that means between 2020 and 2021, California added **412,059 NEW GUN OWNERS.** That is an increase of 32% in 2020 and 24% in 2021 – and that's using only partial data from the Department of Justice (through March 2021). Clearly, the numbers would be considerably greater with the inclusion of eight additional months.

Whether it was the illogical "defund the police" movement, Leftist district at-

torneys failing to prosecute crimes or the profound uptick in violent crimes (such as murder), the face of the Second Amendment community is being radically transformed – and that scares the pants off the Left.
